

Instructions For Use

- This product is to be used by authorised industry trained personnel only.

It is recommended that **BALMORAL**™ Mats and Covers Bags should be cared for in the following manner:

Storage:

To prevent premature wear of the Mats and Covers Bag, During work store away from direct sunlight.

Note: other storage methods may be suitable, however, if these methods have not been approved by Balmoral, then the customer takes full responsibility for their suitability.

- We recommend that Mats and Covers Bags be stored in a clean, temperature stable environment away from sharp objects, sunlight, ozone and steam.
- Kept clear of all oil based products and hydrocarbon derivatives.

Use:

- Prior to commencement of work, Mats and Covers Bags should be visually inspected for any defects. Please refer to the section "Periodic Visual Inspection and Care".
- Should the item be found to have a defect, the Mats and Covers Bag should be removed from service.
- See below "Periodic Visual Inspection and Care" instructions for further directions on how to clean and inspect Mats and Covers Bags.

Periodic Visual Inspection and Care:

• It is recommended that where it is possible or practical to do so, all Carry Bags be periodically inspected, cleaned and then re-inspected. This periodic inspection is recommended to take place every 6 months and should be an adjunct not a replacement for the routine (prior to use) inspection.

To aid visual inspection, materials should be:

- o Cleaned to remove grime and dirt which may otherwise hide potential defects.
- o Items removed from the Carry Bag and placed away from the work space.
- Carry Bags should be cleaned using a dedicated PVC material cleaning fluid or mild detergent.
- If any component of the Mats and Covers Bag is found to be defective, it should be removed from service.
- Defects may take the form of embedded objects, fraying, rust, cuts, tears or any other form of aging or damage.

Zippers:

- It is especially important that zippers are cleaned regularly to ensure they remain free from debris and/or rust. Failing to clean the zippers regularly can lead to accelerated rusting and damage to the zipper teeth.
- While the zipper teeth are made from non-conductive materials, this should not be relied upon. Caution that the zipper slider is conductive.

Velcro:

• It is especially important that Velcro is cleaned regularly to ensure a proper connection.
